New Developments Coming to Brooklyn

Best Wishes to police Chief Jack Murphy. Chief Murphy is retiring after 40 years of dedicated service to the community. Thank you for a job well done. Thirty-three year veteran, Mark Tenaglia has been named his replacement.

There are two new developments on the near horizon for the City of Brooklyn Division of Fire, and for the community it serves. These improvements will be beneficial to both the citizens as well as our business residents.

The first is a new Emergency One "Bronto" 100' aerial tower truck. This apparatus will combine elevated operations along with ground and elevated heavy rescue operations. A committee of Fire personnel was formed to research the best unit to suit the protection requirements of the City. It was during this research that it was decided to combine aerial operations with heavy rescue capabilities. This unique concept will maximize functional capabilities with limited resources. The total cost of the "Bronto" with equipment is roughly \$850,000.00. This truck is currently in production and the anticipated delivery date is late September/early October.

The second development is a new 24,000 square foot Fire/

EMS Headquarters currently under construction at 8400 Memphis Avenue. A report titled "Existing Fire Station Facility and Space Needs" completed 1/03 by DLZ Inc. concluded "The existing facility...is vastly limited in life span, size, and capability". Then a comparative analysis titled "Remodeling/Expansion of the Existing Fire Station Versus a New Fire Station Building" completed 8/03 by R.C.U. Architects Inc. recommended "...design/construction of a new Fire Station facility would best satisfy the needs and requirements of the Fire Department and the City of Brooklyn. The cost differential between the similar size remodel/expansion and a new station is a small amount of monetary value." To date, the estimated completion cost of the new station is \$5.6 million dollars with a target completion date of 11/15/06. This project is currently on time and on budget.

An increase of 1.5 mills in real estate tax was approved by an

advisory vote of the residents during the 11/04 election by a margin of 55%/45%. Revenues generated by this increase will fully fund the new "Bronto", the new Fire/EMS Headquarters, and the safety forces pension fund.

The ISO (Insurance Services Office) rates fire departments on their ability to provide protection to the community. The City of Brooklyn is currently rated a 3 on a scale of 1 to 10 with 1 being the best. We are one of only several that have a rating this high in Cuyahoga County. This directly impacts and lowers insurance premiums for our business residents.

make certain the Mayor and Superintendent understood the issues facing them in today's business climate.
