## **Teacher Grant Awarded**

The Brooklyn Chamber of Commerce offered a \$500 grant opportunity for any teacher in the Brooklyn City School District this spring. The 2011 Educator Grant was a testimony to the fact that the Brooklyn Chamber understands the financial constraints of many in the educational field and chose to offer an avenue of financial support for a teacher or a group of teachers. The teachers were required to write a lesson idea which outlined a need, a purpose, a solution, and a product which would enable their students to value a project-based unit of instruction with real-life application. In 1,000 words or less the teachers described an idea with details, how it corresponded to the State Standards, the needed resources and how it provided an authentic learning experience. Eight teachers applied for the grant.

As the recipients of the grant, the second grade teachers identified the five indicators in the second grade that deal with the field of economics. Students would be required to read books about producers, consumers, goods, services, jobs, money and manufacturing at their reading level while creating flowcharts of necessary resources. Eventually the students would participate in a

classroom factory project. Each of the stations in the factory would be an ingredient in a "Bee Ready Bag." Items such as flashcards, puzzles for word lists, and a memory book to prepare for third grade would be in the bag. At the conclusion of the factory proiect, students would use their "income" from their factory job to buy the finished bag.

Relay For Life is our signature fund-raising event. where people from all different aspects of the community can come together to fight back against cancer. What makes this event so great is that anyone and evervone are able to participate! Teams usually consist of 10-15 people from groups of families, friends, schools, churches, businesses, and other organizations with the goal of each participant being to raise at least \$100. To make it a relay, one member of the team must be walking the track at all times.

For Life of Brooklyn by having our cancer survivors, our reasons for why we do what we do, take a ceremonial first lap after the opening remarks. They are then treated to a Survivor Reception, typically donated by a local restaurant. That is only the beginning though, as a fun night of music, contests, karaoke, team fund-raisers, and a Midnight Meal lies ahead.

Later in the evening we **remember**, as our Luminaria are set lining the track, and are illuminated during a ceremony as we honor our cancer survivors, remember those that we have lost, and support those still battling this disease. The Luminaria ceremony is a significant highlight of the event as it gives participants a chance to reflect on our common purpose of wanting to save lives by finding a cure.

Remember, cancer never sleeps. This is an 18 hour, overnight event, so our teams do bring tents, food, games, and a positive attitude to get them through until morning when we have our **Fight Back** ceremony.

## LOCAL COMPANY WINS STATE HONORS

The Sausage Shoppe, a local meat processor and retailer, won two Awards at the recent Ohio Association of Meat Processors (OAMP) Convention in Columbus, OH on March 26, 2011.

Reserve Grand Champion is the award The Sausage Shoppe received for its Restructured Jerky, with an entry of their original recipe Beef Jerky. The jerky is judged based on external appearance, internal appearance & texture, aroma, flavor and texture & mouthfeel. The beef jerky received high marks for

uniformity of color. This is the seventeenth state or national award for this product.

The Sausage Shoppe placed First in the Innovative Products class. Spicy Cheddar Kielbasi was submitted for this category. This class is judged based on appearance & presentation, feasibility to manufacture, aroma, flavor & texture, and being an innovative idea within the meat industry. Spicy Cheddar Kielbasi is a combination of lean beef and pork, Italian spices, and a blend of fine and coarse shredded cheddar cheeses. It is fully cooked and smoked.

The convention was attended by Al Heinle, who is on the OAMP Board of Directors. He attended sessions on social media marketing, workers comp, workplace safety, and industry trends. A hands-on demonstration discussing loaf, jerky, and summer sausage recipes and processing techniques was also attended by Al.

For more information about Polaris please call (440) 891-7609 Two Polaris Chef Training teams recently competed in the ProStart Culinary and Restaurant Management Competitions in Columbus, Ohio. This annual contest, which is presented by the National Restaurant Association Educational Foundation (NRAEF), allows students from programs around the state to showcase their culinary and academic talents.

For the second straight year, Polaris placed first in the Culinary Team event and will represent Polaris and the state at the national competition in Overland Park, Kansas on April 29 through May 1, 2011. During the statelevel challenge, the Polaris team had to present a three course meal to a panel of certified chefs and exhibit comprehensive skills in communication, teamwork, organiza-

tion, safety and sanitation. They only had one hour and two electrical hot plates to complete the task. No ovens or open flames were permitted. The championship team consisted of Douglas Ferrell, senior, Olmsted Falls High School; Domenic Hrezik, senior, **Brooklyn High School:** Shannon Martincic, senior, Berea High School; lan McCaffrey, junior, North Olmsted High School: and Austin Zavodny, senior, Fairview High School. As the first place team, the students were awarded over \$108,000 each in college scholarships to numerous renowned culinary schools.

Polaris Chefs Win Top State Honors

Polaris also had a team compete in the Restaurant Management event. In this competition, each team had to present a restaurant concept from

the ground up, including a business plan, marketing concepts, a verbal presentation and visual display. Each team also had to answer questions from an expert panel. The Polaris junior team took home third place honors and were awarded \$10,000 each in college scholarships.

In all, the Polaris students received scholarship awards totaling over \$580,000 from the following culinary schools: Baltimore International College, Indiana University of Pennsylvania, Johnson & Wales University, the Culinary Institute of America. the National Institute for Culinary Arts, the Chef's Academy, Columbus Culinary, International Culinary Schools and Sullivan University.



Thirty-five students from Polaris Career Center recently competed in the SkillsUSA Regional Competition at Lorain County JVS in Oberlin, Ohio. Each year, this event gives students from Northeast Ohio the opportunity to display their skills in specific careertechnical training areas. This year, hundreds of students from schools around the region competed in over 25 different skill contests. Students who finished in the top three in each event will represent Polaris and the North Central Region at the State SkillsUSA Competition in Columbus on April 29 -30. There were a total of 26 Polaris winners and state qualifiers. These students will be joined by 24 "straight -to-state" competitors. In all,

50 students from Polaris will be competing at the state level, the highest total in recent memory. Brooklyn High School senior, Andrew Biondo, placed 3<sup>rd</sup> in the "Team Works (team of 4)" contest. Andrew currently participates in the Construction Trades program at Polaris.





The old Chinese proverb or curse, one that has a mixed message, "May you live in interesting times", is so true with recent passage of SB5, and some of the other bills that have recently been passed or in the process of acceptance by the Ohio Legislature. As you might be aware, the budget proposal for school funding for the next biennium (HB 153) will contain an accelerated schedule for phasing out replacement funds that are currently being used to offset the (TPP), or Tangible Personal Property taxes being lost, along with the (TUPP) tangible personal property tax revenue being lost.

Historically, school districts received about 25.4% of the kilowatt-hour revenues, while the Ohio General fund receives about 63% of that same total revenue. Under the new bill, the General Fund will receive about 89% of the revenue, while the school districts are scheduled to receive about 8% in 2013.

In addition to these revenue losses by school districts, we will see a reduction in commercial activity tax revenue (CAT), which accounts for 70% of the funding for the SDPTRF, and instead, 100% of CAT funds will be phased and redirected to the General Revenue Fund over time. Since Brooklyn is considered a "wealthy" School District by state standards of valuation, we stand to lose the most, along with many School Districts here in Cuyahoga county and beyond. The offsets provided still show us losing over 2.3 million dollars in the next two fiscal years.

We are in a new age that challenges the ability for administrators and Boards to shuffle funds around, especially when 80% or more is spent on payroll and benefits. There is some relief provided by SB 5 to retool how we spend money on these line items, but in reality it is a severe cut in spending. Because of our current state of economy here in Brooklyn and surrounding communities, it would not be prudent at this time to go back to the voters to ask for an increase, nor ask them in spite of immediate need, to pass a Bond Issue for our new Middle school at this time. In fact, our Board and our administration is looking at a new paradigm shift on how we educate our students using technologies, and finding new opportunities to be competitive in school education delivery.

This is not your mother's schoolhouse will ring true in the next few years as we strive to deal with the immediate impact of funding reduction; but also see opportunities to blow up the "traditional" and place our students in an environment that will prepare them for the future, together with a staff that is thinking outside the box on how best to teach and to learn. As someone who has been given the keys to our children's door of learning, I ask for your patience and continued support. We certainly live in interesting times!
