Keeping "Success in Succession Planning"

On September 20, 2007, Loree Connors, CPA for Vita-Mix, spoke at our luncheon on the topic of Succession Planning. She gave some excellent ideas and strategies for business owners. The focus of her presentation was on the 5 tip plan detailed below. You can read her full presentation on our website at http://www.brooklynohiochamber.org/bulletinboard.htm

The 5 tip plan for successful succession transition starts with early planning (5 years is good, 10 years is better). The longer the time is spent on the plan the smoother the transition. Dialogue among family members and others is crucial. It is important to have many conversations with family members and pay close attention to the personal feelings, ambitions and goals of the family members, as well as the key employees. It can be a good idea to hire an objective facilitator who can draw out the conversation in areas where it can be touchy. Another good idea is take a confidential survey of potential candidates to determine their aspirations. Family retreats are a great way to start dialogue in a structured and planned environment. This is a good way to present topics that can sometimes be difficult discussions. Being away from the business and in a relaxed atmosphere can get the conversations going. Look realistically at family members. The successor must be a good fit for what the business needs going forward. Training and experience is critical for the person taking over. It is a good idea to gain job experience outside the firm so that the person has broad experiences that they can contribute to the organization. Higher education and training can also be beneficial. Fair does not have to mean equal. Many business owners think that if they have three children, they have to transfer their shares equally so that each child owns 1/3 of the business. This may not be in the best interest of the business. Is it fair to have the daughter who is named the CEO to have to constantly get the agreement of her siblings on major decisions? During the succession planning process, it is important that the management decisions about running the company are made first. Then the decisions about how the stock should be owned can come afterward. Disengage after the decision is made. Overcome the resistance to change and to new ideas. Understand that the younger generation may tend to be less risk adverse because they are optimistic about the future and have a longer time horizon to recover from potential mistakes. This is not a wrong perspective necessarily, just a different one. Once the succession decision is made, develop an exit timeline. The idea is to exit with style and 1. don't overstay your welcome.
